

# FilmG Consent Form



If you are:

- **under 16 years of age**  
*or*
- **entering a film on behalf of anyone under 16 years old**  
*or*
- **entering a film in which anyone under 16 years old appears on screen**  
*or*

then consent from a parent or guardian is required for you or each participant who is under 16 years old. See **Section 1** to give consent.

If you are:

- **over 16 years of age**  
*or*
- **entering a film in which everyone that appears on screen is over 16 years old**

then you can give your own consent. See **Section 2** to give consent.

If both scenarios apply to you, for example if your film involves individuals both ***over and under the age of 16***, then please fill out both sections **1 & 2**.

## Section 1.

My child and I are happy for my child's image to appear in all FilmG promotion and any future promotion of the competition. I can confirm that we have read or been made aware of the organisation's photography and video policy. I can confirm that we have read or been made aware of how the organisation will use these images or videos.

My child and I consent to their image being featured in the BBC ALBA Awards broadcast, should their film be shortlisted. I, the Contributor, agree to CGS /MG ALBA sub-licensing and assigning the benefits and rights granted herein to any other subsidiary or associated company or affiliated party or as required to exploit the Content. I, the Contributor, understand there is no obligation by CGS /MG ALBA to exploit or use the Content.
